How does CBW Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. Non-Affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. CBW Bank does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between non-affiliates financial companies that together market financial products or services to you. CBW Bank does not jointly market.
